Discover® Network Changes Update

Bulletin: PPMD-091506.1

As an update to the Global Payments 2005 Fall Compliance Bulletin (PPMD-103105.1) distributed on October 31, 2005 and the Discover Network® Changes Compliance Bulletin (PPMD-062606.1) distributed on June 26, 2006, this notification is to advise you that the Discover Network® has sent another notification amending the new Issuer Identification Numbers (IINs) for acceptance as of October 1, 2006 (see attached letter from Discover dated September 12, 2006).

The following list has been updated to reflect the existing 6011 range and the new IIN ranges.

Timeline

10/01/06 - All vendor applications certified to Global Payments Hosts which support Discover Card transaction processing must be ready to accept the new Discover IINs.

Impact/Action - Certified Application Providers

- 1. Modify POS application(s) to recognize new Discover IINs ranges by 10/01/06.
- 2. Contact Global Payments Product Integration Group at product.integration@globalpay.com to request a copy of latest specs for testing purposes before 10/01/06.
- 3. Notify merchants of upgrade to application(s) and convert as appropriate.
- 4. If you have already programmed any of the above-referenced ranges requested by Discover to be removed into your merchants' POS devices, please be advised that <u>any Authorization requests will be declined on Cards with numbers in those ranges</u>. In addition, when your systems are next updated, the ranges indicated above should be removed.
